

### TIPS TO AVOID SCAMS

Phone scammers or other trickers either on-line or in person are more sophisticated than ever. Be vigilant with these easy tips provided by the Federal Trade Commission to avoid being scammed. Look for the 4 Ps..

# 1.Scammers <u>PRETEND</u> to be from an organization you know.

Be suspect, verify and know the scammer will pressure you to believe them. Do not be fooled.

# 2.Scammers say there's a <u>PROBLEM</u> or <u>PRIZE</u>

Before taking any action, pause, wait and verify.

#### 3.Scammers <u>PRESSURE</u> you to act immediately.

As a rule of thumb, Nothing requires immediate action. If you are being told to act immediate, then ask for a time out to verify the need for action is actually present. Disconnect from the scammer.

## 4.Scammers tell you to <u>PAY</u> in a specific way.

Never pay someone who insist you pay ONLY a certain way. Never give out financial information to a third party without using a website you trust and with verification.

Stop and talk to someone you Trust. Be alert for the 4 Ps.
